WORK COMPLETED:

Project Management

Task 1. Literature review (100% completed)

A revised literature review was submitted for panel review again in December 2016. It highlights current practices, innovative practices, and trends related to materials used, their application rates, and the application methodologies and equipment under various road weather scenarios (temperature ranges, storm conditions, and other climate and operating conditions).

Task 2. Interview Plan (100% completed)

In December 2016, an updated interview plan was submitted to the panel for review.

Task 3. Interviews (100% completed)

The interviews were conducted with more than 35 agencies and an interview memo was submitted in Sept. 2017. The detailed notes of the interviews are also available upon request by the panel.

Task 4. Guidebook (100% completed)

The final revisions were made to the Guidebook in the last quarter and all review comments were addressed.

Task 5. Final report (99% completed)

Revisions were made to the Final Report in the last quarter. Final discussions are taking place within the project subcommittee. Final approval is expected by April 30th.

The report summarized all the methodology and findings from tasks 1 to 4.

Task 6. Final presentation (100% completed)

The final presentation was conducted by Michelle Akin in Feb. 2019, with the assistance from the entire project team.
